

2025 DEMONSTRATION GUIDELINES

To ensure a smooth and professional experience for all exhibitors and attendees, please adhere to the following guidelines when conducting demonstrations at the trade show:

1. Scheduled Demonstrations Only (20)

- All product demonstrations must be conducted according to the official schedule.
- Demonstrations are not permitted during scheduled demo times to prevent disruptions.
- Exhibitors wishing to schedule a demo must coordinate with event organizers in advance.

2. Outdoor Power and Audio Usage

- Exhibitors requiring outdoor power must obtain their own power source.
- Exhibitors needing audio equipment must bring their own, as it will not be provided by the event organizers. Examples include:

3. Space and Safety Considerations

- Demonstration areas must be kept clear of obstructions to allow for attendee flow and emergency access.
- All equipment and materials should be safely secured to prevent accidents.
- Any demonstrations involving hazardous materials or actions must comply with venue safety regulations and receive prior approval.
- Demonstration areas must be treated as an active work area. Standard safety procedures must be practiced at all times.

4. Engagement and Professionalism

- Demonstrations should be engaging, informative, and conducted professionally.
- Any complaints regarding demonstrations should be directed to event organizers for resolution.

5. Demonstration Insurance

6. Inclement Weather

 All PipeLive Rehab demonstrations are performed outdoors. There are two indoor classroom spaces available in case of inclement weather. We ask that all scheduled demonstrations have a backup plan – indoor appropriate demo or presentation – if we must move indoors. Presentations will be done indoors, on stage and limited to 35 minutes due to scheduling constraints.

Failure to adhere to these guidelines may result in limitations on demonstration privileges. We appreciate your cooperation in creating a productive and enjoyable trade show experience for all attendees.

2025 PipeLive Rehab Demonstrator, Exhibitor and Sponsor Indemnification and Insurance Terms and Conditions

Payment Deadlines

A 50% non-refundable deposit is required to be paid with the submittal of the signed contract. No company will be acknowledged or promoted, either in print or on the PipeLive Rehab website until the contract and required deposit have been submitted and processed.

Full payment is due no later than May 1, 2025. Demonstration, exhibit and/or sponsorship will be released by Benjamin Media if unpaid balance exists after May 1, 2025.

Payment in full is required for any demonstration, exhibit space or sponsorship contracted after May 1, 2025.

Payments may be made by credit card, ACH, or checks made payable to Benjamin Media, Inc., and mailed to 3554 Brecksville Rd. Suite 200, Richfield, OH 44286.

Demonstrator, Exhibitor and Sponsor Cancellation Policy

Please sign and date to confirm your acceptance of the above terms.

Any cancellation request must be submitted in writing to dsisko@benjaminmedia.com. For demonstrators, exhibitors and/or sponsors paying the full Fee and canceling before May 1, 2025, a 50% refund is available. All other fees are non-refundable.

Demonstrator, Exhibitor and Sponsor Liability Insurance Requirements

As a standard requirement for all demonstrators, exhibitors and sponsors, you must carry general liability insurance coverage from an insurance company in good standing with a minimum policy limit of \$1,000,000 per occurrence and \$2,000,000 aggregate.

This insurance must be in force during the dates of the event naming Benjamin Media, Inc. (3554 Brecksville Rd., Suite 200, Richfield, OH 44286) as the certificate holder. Both Benjamin Media, Inc., and Doetsch Environmental Services must be named as additional insured.

Demonstrators, exhibitors and sponsors must maintain Worker's compensation insurance in full compliance with all Federal and State laws covering all employees and Independent Contractors.

Indemnification

Each party represents and warrants that each person executing this Agreement is authorized to do so and is acting within the scope of his or her authority to bind said party under this Agreement.
